Big Changes, Big Emotions, Big Behaviors

Early childhood educators are experiencing changes and reflecting on child behavior since COVID. In this session, we will talk about the behavior challenges and changes in the classroom since COVID and ways to address these changes through strategies and changed mindsets.

Biting 101

Trying your best to understand the underlying cause of a toddler's biting will help you develop an effective response. Children bite in order to cope with a challenge or fulfill a need. What does it mean? Understanding child development? How to respond?

Communicating Through Behavior

All behavior has meaning. Many times, the challenge is interpreting what children are trying to communicate through their behaviors. During this training we will explore the meaning behind the behavior, as behavior is the most common way that children communicate their emotions, wants, and needs to adults. It is our responsibility to support and guide them as they communicate through behavior.

Program for Infant Toddler Care (PITC) Module 1: Social-Emotional Learning & Socialization

Social-Emotional Growth and Socialization explores topics on social-emotional development in the first three years, temperaments of children and caregivers, socialization, guidance and discipline, environments, and gaining an understanding of children's behavior. Training will begin with an overview of the basic concepts of early social-emotional growth and socialization and their application to the group care context. An emphasis is placed on the development of a nurturing relationship between the infant and caregiver. The overview addresses the importance of responsive caregiving, the individualization of care through an understanding of infant temperament, the critical role of family and culture in early identity development, exploring developmentally appropriate play strategies with ages of infancy, creating supportive physical environments, and stages of emotional development. --- This is a hybrid training and participants must complete the fact to face session and online assessment to receive credit.

Level of Learning: Intermediate

Program for Infant Toddler Care (PITC) Module 2: Group Care

Group care introduces special considerations in caring for infants and toddlers and six program policies that support the development of emotionally secure relationships and mental health in the group care setting. An overview of the content of Module 2 explores the ideas of primary care, well-designed learning environments, positive impact of responsive caregiving routines, and individualized care on the well-being and development of children birth to age three. Attention is also given to how the policies of primary care, small groups, continuity of care, culturally responsive care, and inclusive care of children with special needs prove the foundation for high quality infant/toddler care. At the end of this module, participants will have the tools to use primary care in their home or classroom, make engaging environments, assist children in daily routines, and individualize care for all children. --- This is a hybrid training and participants must complete the face-to-face session and online assessment to receive credit.

Understanding Children's Temperament

Temperament is the way children respond to the world. It influences the way children handle emotions, regulate behavior, feel around new people, and adapt to new situations. You can nurture a child's development by using strategies that suit their temperament. Nevertheless, the behavioral adjustment of young children depends a lot on the interactions between their temperament and yours and how others will respond to them-how comfortably they fit within their environment and the people around them. We will explore children's temperaments and how to respond.
