An Introduction to Contracts and Policies for Child Care Centers

Do you need to write your first contract or policy for your center? Do you have an existing contract or policy but are wondering if it has everything you need? In this training, we will identify the difference between contracts and policies, give examples of what goes into them, and apply the information to new contracts and policies.

Audience: All Center Providers, including Center Leadership

Level of Learning: Introductory

Circle of Security

This series consists of four training sessions using an eight-chapter reading, video, and interactive discussion on an attachment approach that helps build caregivers' capabilities to view young children's behavior from a secure base and safe haven perspective and then identify the child's needs, challenges, and strengths. This enables caregivers to increase positive attachments with the children in their care, thus supporting positive developmental outcomes for young children. --*Participants must attend all four sessions to receive credit.*

Audience: All Providers

Level of Learning: Introductory

Program for Infant Toddler Care (PITC) Module 4: Culture, Families, and Providers

This training focuses on culture and its implication for families and providers. Participants will learn how family experiences, knowledge, and childrearing beliefs and practices can be incorporated into early care and classroom settings. Cultural expectations and biases will be explored, and participants will have the opportunity to increase their cultural awareness in terms of how their assumptions may affect their interaction with young children and families. Participants will demonstrate their understanding of how family structures, diversity in social, cultural, linguistic, or religious backgrounds influence family approaches to parenting in children birth to three, each other, and the community. Participants will understand how relationships among caregivers, infants/toddlers, and families can impact other child-family, child-practitioner, and practitioner-family relationships. --- This is a hybrid training and participants must complete the face-to-face session and online assessment to receive credit.

Audience: All Providers Caring for Infants, Toddlers, and Twos

Level of Learning: Intermediate

Recognizing Traumatic Stress in Young Children

Children are more vulnerable to being traumatized by accidents, pandemics, violent crimes, and other disasters. But with the right adult support, they are also able to recover faster. We will look at recognizing the signs of child traumatic stress and the impact that trauma may have on children. We will look at information on the prevalence and impact of traumatic events on children and what actions can be taken to support children when they experience traumatic events.

Level of Learning: Intermediate
